This Privacy Policy also makes disclosures concerning IMO's collection of information, including personal information, when you use the Application, and how we use and disclose it to others. By using the Application you accept the practices described in this Privacy Policy.

By using the Application, you consent to the use of information that you provide us in accordance with this Privacy Policy. We do update this Privacy Policy from time to time so please review this Privacy Policy regularly. If we materially alter our Privacy Policy, we will notify you of such changes by contacting you through your user account e-mail address and/or by posting a notice within the Application. INFORMATION WE COLLECT

We collect personal and non-personal information when you provide it to us in the course of using the Application. We collect information that you provide to us which includes:

- (a) your name and email address;
- (b) your address and phone number and your payment method; and
- (c) communications by you to us regarding the Application or any of our services or products.

We automatically collect information regarding you and your use of the Application, including:

- (a) details of your visits to the Application and the resources you access, including, but not limited to, your Internet protocol (IP) address, traffic data, location data, weblogs and other communication data, the date and time you accessed or left the Application, term searches and other use of the Application;
- (b) details regarding your interactions with customer service, such as the date, time and reason for contacting us, transcripts of chat conversations, and if you call us, your phone number; and
- (c) information collected via the use of cookies (described below) and other technologies.

OUR USE OF YOUR INFORMATION

The information that we collect and store relating to you is primarily used to enable us to provide our services to you in the best possible manner. In addition, we may use the information for the following purposes:

- to communicate and provide you with information relating to our services or products (for example email notices regarding subscription renewals) and to offer you additional products and services;
- (b) to provide third parties with statistical information about the users of our Application;
- (c) to monitor and conduct an analysis of our Application traffic and usage patterns; and
- (d) to analyze trends and to improve our service.

OUR DISCLOSURE OF PERSONAL INFORMATION TO THIRD PARTIES

We may disclose your personal information to any affiliated business entities or third parties necessary to provide products and services to you. We may also disclose your personal information to other third parties, such as:

OUR USE OF COOKIES
